

# SHIRE OF JERRAMUNGUP RECOGNISED FOR BEST PRACTICE BY OFFICE OF AUDITOR GENERAL

The Office of the Auditor General (OAG) recently released its whole of Local Government audit findings for the 2021-22 financial year.

This report to State Parliament summarises the final results of the OAG's annual audits of most local governments for the year ended 30 June 2022.

For the first time, this year's OAG report included a list of the top 20 of the 146 local government entities in WA achieving 'best practice' for 2021-22.

The Shire of Jerramungup was recognised in the top 20 for timeliness and quality of financial reporting and controls.

OAG Audit General Caroline Spencer said 'I congratulate these entities for their commitment to timely and quality financial reporting to their communities. I particularly acknowledge and commend the number of regional shires that have made this inaugural list, given the extent of resource and labour constraints that can disproportionately affect our regions'.

The performance of the Shire was acknowledged across a number of criteria including the timely preparation for audit, high quality financial and maintenance of good financial management controls.

Shire President Joanne Iffla said 'This is fantastic recognition of the Shire of Jerramungup and in particular our Finance Team, who consistently strive for best practice in financial reporting.'

'For a small, rural Shire such as ours to be listed in the top 20 local governments in the state is an amazing achievement, and our staff are to be congratulated for their efforts.'

Shire CEO Martin Cuthbert said 'I would particularly like to mention Charmaine Solomon, Deputy Chief Executive Officer, and Tamara Pike, Senior Finance Officer, whose high standards have resulted in this outcome we can all be very proud of.'

#### **CSRFF Application—Jerramungup Sports Club**

At the August 2023 Ordinary Council Meeting, Council was requested to consider an application from the Jerramungup Sports Club for grant funding under the Community Sport and Recreation Facilities Fund (CSRFF) grants program for the construction of a new ablution block to be located at the Jerramungup Sports Complex.

The application to the CSRFF proposes the construction of an accessible and unisex ablution block between the Bowling Club shed and the Hockey oval. It has support from all the key users of the area.

As part of the application process, Council is required to assess and rank the application for formal lodgement with the Department of Local Government, Sport and Cultural Industries.

If the project is successful in achieving funding through the CSRFF, Council's 2023/2024 budget includes provision for a cash contribution. In addition, in the event of a successful outcome, it is proposed that the Shire commit to maintaining the asset into the future to ensure the facility can be open to the wider public all year round.

#### Works

- Rabbit Proof Fence Road—Completed re-sheeting a 3km section.
- Jacup North Road—Started a gravel re-sheet of a 3km section.
- Maintenance of Swamp Road, Devils Creek South Road and Boxwood-Ongerup Road..

#### **Town Services**

#### **Bremer Bay**

- General maintenance activities of parks, gardens and reserves, including:
  - ⇒ Weed control along footpaths and roads.
  - ⇒ Pruning of street trees within the townsite.
  - ⇒ Coastal reserves maintenance, including the removal of rubbish, weed control and pruning of vegetation.
  - ⇒ General rubbish removal throughout the townsite and along Point Henry and Wellstead Roads.
  - ⇒ Revitalisation projects of Pelican Park Gardens and the Bremer Bay CRC front garden.

#### Jerramungup

- General maintenance activities of parks and gardens, including:
  - ⇒ Weed control, rubbish removal and pruning of street trees.
  - ⇒ Revitalisation project of the Jerramungup CRC grounds, and gardens near the Chemist.
  - ⇒ Weed control and pruning of overhanging vegetation throughout the Jerramungup laneways.
  - ⇒ Removal of graffiti from signage along the South Coast Highway.
  - ⇒ Street maintenance, including filling in potholes and clearing of drains.

#### Environment

- Follow up of fauna surveys within the fire mitigation zones of the Boxwood Hill region. Identified successful breeding of two pairs of the Endangered Western Whipbird. Both active nests supporting young were located just beyond the fire application zones. Note: The Shire of Jerramungup's road reserves support one of the most significant breeding populations of the Endangered Western Whipbird.
- Over the next couple of months, weed control activities will focus on Vic Tea Tree control within environmentally sensitive areas, including areas along Swamp Road and along the access road to the Bremer Bay Airfield.
