# TOTAL FIRE BANS & HARVEST BANS, WHAT'S THE DIFFERENCE?

#### **TOTAL FIRE BAN**

A Total Fire Ban (TFB) is declared on days when fires are most likely to threaten lives and property. This is because of predicted extreme fire weather or when there are already widespread fires and firefighting resources are stretched. A TFB is declared by DFES following consultation with local governments.

A TFB prohibits the lighting of any fires in the open air and any other activities that may start a fire. The ban includes all open air fires for the purpose of cooking or camping. It also includes incinerators, welding, grinding, soldering or gas cutting. Exemptions may be allowed for some industries and activities with conditions applied.

Recent changes to TFB regulations have been introduced that broaden the activities farmers can undertake during these bans.

The changes mean farmers can now continue day-today agricultural activity such as harvesting, as long as a Harvest and Vehicle Movement Ban has not been implemented by their local government.

On days when a Total Fire Ban and/or a Harvest & Vehicle Movement Ban are in place farmers are still able to check on the welfare of their stock, including moving livestock between paddocks to a water source, providing the vehicle being used is equipped with a portable fire unit carrying a minimum 600ltrs of water. Certain activities likely to create a bushfire danger such

as operating an oxytorch, welding and operating grinders in the open air are still banned.

#### HARVEST AND VEHICLE MOVEMENT BANS

Harvest & Vehicle Movement Bans (HVMB) are issued by local governments under the Bush Fires Regulations 1954 Section 38A, and/or Section 24C. It is the responsibility of the farmer to be aware of any bans in place before harvesting as you could be fined for breaching a ban.

Local governments will impose the ban when their Chief Bushfire Control Officer identifies the use of engines, vehicles, plant or machinery as high bushfire risk activities likely to cause a fire or contribute to the spread of a bushfire. These times are called prohibited burning times and/or restricted burning times and vary between the individual local governments. The prohibited and restricted burning times vary between local governments, see local times below;

A HVMB may be imposed for any length of time but is generally imposed for the 'heat of the day' periods and may be extended or revoked by the local government should weather conditions change.

As the farm owner or machine operator, you are responsible for checking whether any restrictions are in place before you undertake harvesting on your property. It is your duty to make sure your equipment is not likely to start a fire during a ban. If it does, you could be fined. But more seriously, you would be responsible for putting your property, family and community in danger.
