# 6. PROJECT UPDATE

# 6.1 Bremer Bay Town Centre

Bill Parker advised that Stage 1 of the Bremer Bay Town Centre is now complete. Landcorp have valued the blocks and there are now 2 blocks on the market. No offers have been received at this stage.

Bill Parker advised that subsequent blocks could be made smaller or bigger if required to accommodate potential purchasers.

Detailed designed has been completed for Stage 2 that includes extending the main street to Mary Street.

# 6.2 Bremer Bay Civic Square

Bill Parker advised that a civic square was identified in the planning for the Town Centre. The Shire called for expressions of interest to form a Group which consists Councillors, Executive Shire Staff, local community members and Landscape Architects from UDLA. Community workshops were held in February and March.

The location identified for the civic square is on the corner of Seadragon Ave and Yandil Street. The concept design for this space will be presented to Council at the April meeting.

# 6.3 Walk Trail Project

Bill Parker advised the Bremer Bay / Point Henry Shared Use Trail Plan was endorsed by Council at the February Meeting. From here, the Shire will attempt to break the project into manageable pieces and complete one section at a time.

Priority sections have been identified by community memberswith the first section of the trail tobe considered in the 13/14 budget deliberations.

# 7.4 Dieback Management in Bremer Bay (FOWEG+)

Bill Parker advised that at this stage there is no plans for a review, however could possibly look at desktop review. Bill Parker will look into the matter.

Priscilla Broadbent raised concerns from a resident that there is no room left for advertising on the sign located at the Information Bay.

Bill Parker advised Craig Pursey is currently working on the information bay project.

Naomi Hall offered assistance to the Shire to complete the project.

# 7.9 FRNP display board – Information bay

Priscilla Broadbent raised a concern that there needs to be an updated information board on the National Park located at the information bay. There should be more information promoting the National Park as Bremer Bay is the Gateway to the Park.

Bill Parker advised that Craig Pursey would be contacting DPaW as part of the information bay project he is working on to discuss their signage.

# 7.10 Department of the Environment – Proteaceae Dominated Kwongkan Shrubland – Bremer Bay Design & Coordination Group

Dr Ian Weir presented the recent classification of Kwongkan Shrubland as a threatened ecological community.

The report is attached to the minutes for Council attention.

Dr Weir advised that the Bremer Bay Design Coordination Group will be sending in a budget request for the Point Henry Road reserve that is under threat from tea tree.

Bill Parker advised that budget requests need to be received within the next two weeks.
