#### Option 1

Rinnai Demand Duo DDF3 200E 250L =  $3 \times Rinnai HD200e Instant HWS$  (on a frame) connected to  $1 \times 250L tank$ . Enough for 16 showers or outlets with a 600mj/hr gas load = \$11149.00 inc. gst

Normally this system is installed on a Ring Main with a dual flow and return pump extra to quote and depending on pipe work ect. required.

#### Option 2

Rinnai Manifold Pack MP6200EPL (6 x Rinnai HD200e on a Manifold , enough for 12 showers or outlets with a 1200 mj/hr gas load) = \$14675.00 inc. gst <a href="http://www.rinnai.com.au/commercial/centralised-solution/manifold-pack/">http://www.rinnai.com.au/commercial/centralised-solution/manifold-pack/</a>

- be lodged with the Commissioner of Taxation within 60 days from the date of service of this notice.
