7. <u>PETITIONS / DEPUTATIONS / PRESENTATIONS</u>

Mr Justin Bellanger, CEO of South Coast NRM introduced himself and thanked Council for the opportunity to present. Mr Bellanger informed Council that he is currently visiting Local Governments within the region to discuss opportunities for partnership projects.

Past projects between South Coast NRM and the Shire of Jerramungup were brought to light including coastal node planting at House Beach and Doubtful Islands Bay, dieback management and more recently the feral goat cull. With these projects nearing completion the organisation is seeking further opportunities to work collaboratively with the Shire.

Mr Bellanger mentioned Ms Kaylene Parker, South Coast NRM's new Climate Change Project Officer. Ms Parker had recently been in touch with the Shire's town planner Mr Pursey and will soon be visiting to discuss integration with Local Government planning. On closing it was also noted that South Coast NRM had recently been put on the Preferred Supplier list with WALGA.

Mr Bailey thanked Mr Bellanger for his presentation and noted that he was happy to hear that the Organisation had been put on WALGA's Preferred Supplier list as he sees opportunities for South Coast NRM to be involved with on the ground coastal rehabilitation initiatives within the Shire.

Cr Lester thanked Mr Bellanger for his presentation and invited Mr Rob Maroni to present to Council.

Mr Bellanger left the meeting at 2:18pm.

Mr Rob Maroni, Director of Megatime Pty Ltd addressed Council on the Bremer Bay Caravan Parks efforts to find a suitable supply of ground water for supplementary watering of the grounds within the Caravan Park. Mr Maroni advised Council that the Caravan Park's existing water arrangements are not adequate long term, with popularity and traffic levels growing the Caravan Park need additional water to maintain their current standards.

The Bremer Bay Sports Club has lodged an application with the Shire to enter into a sublease with Megatime Pty Ltd to be able to install a bore and pumping facilities within their lease area to the Caravan Park.

Cr Lester pointed out that he drove past the Bremer Bay Caravan Park on Wednesday and commended them on a well-manicured park.

Mr Maroni put this down to successful management of the park and asked if Council would be considering the application from Bremer Bay Sports Club at today's Council meeting.

Cr Lester responded that due to a lack of quorum at today's meeting Council would be unable to consider the item until the June meeting.

ROAD CONSTRUCTION

Gravel re-sheeting on Rabbit Proof Fence Road has been completed and the crew have done a great job with these works which are of a very high standard. Unfortunately the crew lost another week due to the inclement weather.

The clearing on Jerramungup North Road is complete and the next section of re-sheeting will be delivered by local contractors during May.

Bremer Bay Earthmoving was the successful contractor to rectify the flood damage on Devils Creek Road. These works have been and the contractor has done a great job on the sites.

The gravel stockpiling at the Carmichael Road Pit has been completed. There was insufficient gravel at this site so an additional site was located on private property adjoining the reserve. It is greatly appreciated that rate payers are prepared to allow gravel to be sourced from their property for the betterment of the community. Having local access to gravel sources in close proximity to road works expedites improvements and development of future road construction programs.


The 90mm storm water pipe from the southern effluent oxidation pond to the overflow dam has been roughly backfilled but due to the wet weather, the site won't be levelled off until it is dry enough to for a machine to work on.

The fencing around the overflow dam has also been completed.

Brook Road gravel patching has been completed. The scope of these works had to be reduced due to the recent rain and time lost.

Gravel stockpiling for Marnigarup West Road has been completed. Due to the lack of gravel near Boxwood Ongerup Road and the gravel stockpiled for Marnigarup Road, it was decided to change the work schedule and re-sheet Marnigarup West Road before Boxwood Ongerup Road to allow more time to source material.

ROAD MAINTENANCE

The roadside spraying program is still underway on all rural roads ensuring shoulders and drains are clean and ready for winter grading operations with the majority of roads south of Jerramungup townsite towards Bremer Bay completed.

Maintenance grading and gravel patching has been completed in the Bremer Bay and Boxwood Hill areas south of Devils Creek Road. Given the recent rains, the crew will start the winter grading program, building the crown up sufficiently to ensure adequate cross fall in the eastern section of the Shire.

The crew remain focused on clearing of back-slopes especially on bends and intersections to improve sight distances for the road user.

TOWN SERVICES

The town services team has been focusing on the town sites of Bremer Bay and Jerramungup to address the winter weed infestations as a result of recent rains. They are also undertaking maintenance of the parks and gardens in Jerramungup and Bremer Bay.

SUMMARY

It has been noted that a portion of Devils Creek Road currently runs outside of the dedicated road reserve.

It is recommended that Council resolve to:

- Formally dedicate the existing road alignment within a new road reserve; and
- Close the former road reserve and amalgamate it into the adjacent land.

BACKGROUND

A portion of Devils Creek Road that crosses Devils Creek (approximately 2.5km east of South Coast Highway) was realigned at some time in the past. Unfortunately, the realignment was not placed into a dedicated road reserve at the time.

An image of the road to be closed and that portion to be dedicated is attached to this report.

CONSULTATION

Should Council agree to the proposed closure and dedication it will be required to be publically advertised and referred to adjoining landowners and relevant government agencies for comment.

<u>COMMENT</u>

Proposal

Council is asked to consider the following:

- Dedication of the new road alignment under section 56 of the Land Administration Act 1997;
- Close the existing unused portion of Devils Creek Road and support its amalgamation with the adjoining Lot 1476; and
- That the Shire pay any survey/graphic costs.

Comment

The adjoining landowner, Mallee Rise Pty Ltd (Brian Keding) has been contacted and has no objection to the dedication or closure of the roads reserves in question. Mr Keding bought the land after the road realignment and was not aware of the current alignment of Devils Creek Road effectively running through his private property.

The former road alignment is still a track but serves no purpose. Its closure and amalgamation into the adjoining land may be a fair swap.

There will be costs involved in survey, subdivision process and possibly land acquisition if there is a difference in the value of the two parcels of land.



SUMMARY

The Shire of Jerramungup has received a request from the Bremer Bay Sports Club to sublet an area of 15m² to Megatime Pty Ltd. The purpose of the lease is to construct a bore for the extraction of water. The proposal was previously refused by Council in August 2013 following concerns about establishing a bore for the purposes of irrigation based on a recently introduced water wise program and water restrictions in Bremer Bay.

Under the terms of the existing lease, the Bremer Bay Sports Club requires the Shire's consent prior to transferring, subletting or parting with possession of the said demised premises.

BACKGROUND

On 15th April 2015, the Shire of Jerramungup executed a lease with the Bremer Bay Sports Club for a portion of reserve 511. Reserve 511 is a significant parcel of land located to the south east of the Bremer Bay Town Site.

The lease is for a period of 21 years and will expire in April 2036. The lease area is shown provided as an attachment and includes the area bound by the golf course.

On the 11th April 2016, the Shire of Jerramungup received correspondence from the Management Committee of the Bremer Bay Sports Club requesting that Council reconsider their previous refusal for the club to sublet a portion of their lease area to Megatime Pty Ltd to construct a bore for the extraction of water.

CONSULTATION

Department of Water Water Corporation

COMMENT

Megatime Pty Ltd currently leases reserve 21496 (Bremer Bay Caravan Park) from the Shire of Jerramungup. Despite many years searching for water on this site, Megatime is yet to locate a suitable ground water source for lawn irrigation purposes.

Currently the park utilises the towns reticulated water supply to irrigate the extensive grassed areas within the caravan park. If Council was to reconsider their support of the project and Megatime Pty Ltd can secure a water source within reserve 511, they will apply to the Shire to secure land tenure so that a pipe can be run from the bore to the caravan park. The final location of the sublet area will be ascertained following definitive drilling of the area surrounding the sports oval.

Prior to securing land tenure, Megatime Pty Ltd would also be required to complete a bore approval process through the Department of Water.

Council previously opposed the venture sighting concerns about the impact of the proposal on the town's water supply with particular reference to water restrictions and the Water Corporation's water wise program. Since this date the township of Bremer Bay is no longer on abnormal water restrictions but is, like the rest of the state, subject to limited sprinkler days.

As previously stated the Bremer Bay Caravan Park currently utilises the town's reticulated water supply for irrigation purposes. As such the proposal does not envisage any increase in consumption of water and the transferal of the source to the bore would reduce the draw on the town reticulated water supply.

The Bremer Bay Sports Club is also positioned to benefit from this proposal through a sub-lease fee and the future availability of an additional water source. This will represent a level of recompense which would ordinarily have been paid to the Water Corporation for the supply of water.

The Water Corporation and Department of Water have been contacted for comment. Any submission received will be distributed prior to the Council meeting.

STATUTORY REQUIREMENTS

In addition to receiving the Shire's consent, this proposal also requires Ministerial consent under the terms of the management order and lease.

A motion (as recommended) to revoke decision OC130812 will require support from at least 1/3 of the number of offices (3 persons).

 - (2) If a decision has been made at a council or a committee meeting then any decision to revoke or change the first-mentioned decision must be made
 - (a) in the case where the decision to be revoked or changed was required to be made by an absolute majority or by a special majority, by that kind of majority; or
 - (b) in any other case, by an absolute majority.
 - (3) This regulation does not apply to the change of a decision unless the effect of the change would be that the decision would be revoked or would become substantially different.
