9.3 Extension to Restricted Burning Season for the Point Henry Peninsula (See attachment 3)

The local volunteer Bushfire Brigades in conjunction with the Shire of Jerramungup and Chief Bushfire Control Officer have met and discussed extensively the threat of fires escaping in the Point Henry Peninsula from controlled burns.

The Shire sought feedback from landowners on an extension to the restricted burning period in the Point Henry Peninsula. 14 submissions have been received and the majority were in favour of Option 2: (Submission count: 3x in favour of Option 1 - 11x in favour to Option 2)

It is handy for attendance stats for awards/service medals, etc and it is vital especially when volunteers are diagnosed with a form of illness later in life that can be traced back to specific fire. If the volunteer is not listed as being in attendance, it puts the onus back onto the volunteer to prove them self being present at a specific fire.

9.9 Volunteer Training

Mr Ashley Peczka advised training courses will now be held in July, further information will be emailed out/advertised closer to the date. The courses are to be held in Jerramungup and Gairdner.

9.10 Needilup BFB – 4.4 Broadacre Truck

Mr Ashley Peczka advised the Needilup brigade they will be getting their 4.4 shortly.

Dear Committee Members

I am writing this submission to the Bushfire Advisory Committee on behalf of the Fitzgerald Biosphere Group (FBG) Board and its members. For those unaware, the FBG is a local grower group formed by growers to represent growers and FBG Members within the Shire of Jerramungup.

It has been bought to the attention of the board by large numbers of its grower members that the current window for burning is too restrictive in its time frame. Our members have expressed that they would like to see a discussion had about opening the restricted burning period sooner. The consensus of grower members is that the ability to burn earlier in the season would suit the changes in what most would consider best practice weed resistance management.

Our grower members feel that if earlier burning of stubble rows was managed with adequate guidelines it would offer no greater risk of the burning to escape than what there would be as the current rules stipulate.

It is the FBG's opinion that if it can help to facilitate this discussion to ensure it goes ahead in a consultative manner, or offer any assistance to the advisory committee we would be pleased to do so.

In some way I feel lucky for the fire season we have had but a little sombre for the residence of Esperance and Yarloop for the devastation they have had to endure. It irks me when we have to see this type destruction before authorities will act on such things like mitigation and yet they still want to blame someone else for their stuff up (apparently the farmers are to blame as they grow too good a crops in Esperance which created to much fuel load).

Well that's got my gripe off my chest so back to our local fire season. As I said I feel lucky our season was not like some others but believe me ours was the busiest we have had for a while. The following report has been compiled in order to draw Brigade members' attention to some issues which may be of interest.

TRAINING.

Volunteer Fire Fighter Training

DFES Great Southern has prepared its training calendar for 2016. I have pencilled in some training for your Shire in mid-July based upon advice received from Ashley Peczka. Should you require any additional training or specialised courses, please let Ashley or me know.

COMMUNITY FIRE SAFETY.

Miss Sarah Matthews our Community Engagement Officer has requested that I promote the following aspect of community safety with you:

Preparing an Emergency Kit

Having an emergency kit is an important step to prepare and protect your household for an emergency such as a bushfire or Storm.

Keep your Emergency Survival Kit in a storage container in a location that is easy to get to and the whole family knows about.

Things to include in your kit are:

- Portable battery-operated AM/FM radio
- Waterproof torch
- Spare batteries
- First aid kit with manual
- Candles with waterproof matches
- Woollen blankets
- Emergency contact numbers





And don't forget to prepare for your pets as well. Make sure your pet is wearing an identification tag.

If you're leaving, take a leash, basket, medication, food and a familiar toy for your animal.

It will help reduce stress.

Comprehensive Crew Protection Project

By now some Brigades will have had their trucks retrofitted with some elements of the Comprehensive Crew Protection Project. For example most trucks will have been fitted with radiant heat shields and fire blankets. In future appliances will be fitted with some additional facilities including: Water Deluge Systems and Draeger OXY3000 In Cab Air System. In order to give you an insight into what is being rolled out, I have attached the NUCOM guides for the Retrofitted Water Deluge System and Draeger OXY3000 In Cab Air system to this report.

When your appliance has any of these extra systems fitted training will be supplied so that you and your Brigade members know how to use them. It will probably also be a good idea to refresh people on their use prior to the next bush fire season.

NUCOM - Retrofitted Water Deluge System







	NUCOM
N – Name	Retrofitted Water Deluge System *for appliances with greater than 1,500L water capacity
U – Use	Appliance protection spray system for cabin, deck and wheels, to be activated during a burnover.
C – Construction	 Reticulation system (consisting of an electro torque valve, spray filter and head system) Cabin Crew Protection switch and Crew Spray LED panel Cabin spray heads Deck spray heads Wheel spray heads Pump panel spray heads Spray system isolation valve Spray filter flushing valve
O – Operation	In the case of appliances with a live drive system, live drive will be disabled upon operation of the water deluge system and the Auxiliary Pump will automatically start and will run at 3 Bar. For appliances with an independent pump ensure the pump-set is running. Idle speed will be adjusted to run at 3 Bar. To activate water deluge, move the Cabin Crew Protection Switch to on.
	When turned to 'on' the Crew Protection switch will illuminate.

While the water deluge system is functioning the "Crew Sprays Activated" LED will light up green. When the tank is exhausted the "Crew Sprays Activated" LED will turn off.



The Crew Protection switch will also activate the Automatic Vehicle Locator function, if fitted.

While active, All spray heads will produce a misting spray, creating a fog pattern enveloping cab, deck, pumps and wheels.





To turn off the water deluge system, return the switch to 'off'.

Notes: When the crew protection switch is activated the auxiliary pump set will not be able to be stopped from within the cab and in some cases throttle controls will not operate until the crew protection switch is disengaged.





The retrofitted water deluge system runs off the primary tank. Crews must ensure a ¼ tank is available. The water deluge system will require 500L, for single cab and 700L, dual cab to provide 5 minutes of protection. M - Maintenance The water deluge system must be tested once per month and may be flushed using the drain valve. All other maintenance is to be carried out by the regional service provider. Note: The pump has been pre-set to 350kpa. No adjustment is to be made by crew. Consider and constantly re-evaluate LACES throughout operations.






- The unit will start generating oxygen within 1 -2 minutes. If necessary, use your hands to help unfold the breathing bag
 - If the breathing bag does not fill, breathe out powerfully 2 or 3 times from the ambient air into the device
- Hold the In-Cab Air under the KO₂ cartridge and pull on the end of the neck strap in order to pull the In-Cab Air upwards
- Position the In-Cab Air in front of your chest.
 - The device must not be placed too high. However, it must also not pull on the mouthpiece

Goggles: Firefighter issue fire-rated goggles are an acceptable alternative to the goggles included in the In-Cab Air. Remove prescription glasses, if necessary

- If necessary, release the goggles from the device and from the button strap and put them on
- Put the chest strap around your body and close it
- Tighten the chest strap



If you need to vomit, take the mouthpiece out of your mouth and close it with your thumb. Do not vomit into the In-Cab-Air. In order to ensure that no harmful air is inhaled from the environment, first inhale from the In-Cab-Air once the mouthpiece has been reinserted.

M - Maintenance

The following work steps must be performed every day. If one of the criteria listed is not met, the In-Cab Air must not be used. In the following cases, the In-Cab Air may be repaired by trained personnel:

 Make sure that the inspection window is not damaged. A damaged inspection window must be replaced.


In the following cases, the In-Cab Air must be taken out of service or sent to Dräger for inspection.

· Check that the In-Cab Air is intact.





- Check that the seal is undamaged. The seal must not have any stress whitening marks. Stress whitening marks are an indication that the seal is damaged.
- · Check that the casing is closed.
- Check that the opening mechanism is locked and undamaged.
 The snap-fit must be engaged.
- Check that the support ring is tight against the bottom cover of the casing.
- · Check that the seal is not damaged.
- Ensure that the casing does not have any tears or holes.
- Ensure that the bottom cover of the casing does not have any dents deeper than 2 mm.
- Check inspection window: If many yellow fragments, the same size or larger than grains of sugar, can be shaken in the inspection window area, the In-Cab Air must be decommissioned.
- An adhesive, thin yellow layer of particles is normal after years of carrying and does not affect the function.



- Check if the moisture indicator (1) is brown. If moisture has penetrated into the In-Cab Air, the moisture indicator changes from brown to turquoise.
- If the In-Cab Air is equipped with the optional heat indicator:
 - Check that the heat indicator (2) is light. The heat indicator's colour will turn dark if the device has been exposed to too much heat.

SHORTENING OF PROHIBITED AND RESTRICTED BURN PERIODS

Background

Sections 17 and 18 of the *Bush Fires Act 1954 ('the Act')* outline the legislative framework for the declaration and variation of the Prohibited Burning Times (PBT) and Restricted Burning Times (RBT).

Section 17(7) of the Act provides that a local government may, if conditions warrant, shorten, extend, suspend or reimpose a period of PBT. This provision is mirrored by section 18(5) of the Act for RBT.

Section 17(7B) provides that:

A variation of prohibited burning times shall not be made under subsection (7) if that variation would have the effect of shortening or suspending those prohibited times by, or for, more than 14 successive days.

Section 18(5B) of the Act contains a similar provision for RBT.

Current Situation

FESA Legal and Legislation area recently became aware that some local governments have been using the above provisions to vary their PBT with multiple consecutive 14 day blocks. In this regard it also came to light that an excerpt from page 35 of the Fire Control Officer manual relevantly provides that:

There is no limit on the number of times that a Local Government can extend or shorten the Prohibited Burning Times.

In order to clarify the above matter, FESA sought advice from the State Solicitor's Officer (SSO) regarding the interpretation of sections 17 and 18 of the Act.

SSO advise that sections 17(7B) and 18(5B) of the Act use the words 'would have the effect of in reference to shortening of the PBT or RBT. As such, what is important is not just the length of shortening, but the cumulative effect that shortening would have.

By way of example, a local government may do one variation for seven days, and a second variation for seven days. Such variations are within the terms of sections 17(7B) and 18(5B) as the combined effect is to only shorten the period by 14 days.

However an initial 14 day variation, followed by a second 14 day variation, rules the second variation invalid. This is because the combined effect is to shorten the period by 28 days, which is in contravention of sections 17(7B) and 18(5B).

In short, this means where a local government variation of PBT or RBT has a cumulative effect of shortening a period that exceeds 14 days it would be in contravention of sections 17(7B) or 18(5B) of the Act.

Pursuant to section 17(6) of the Act, the Authority may, by notice in the Gazette warrant, shorten, extend, suspend or reimpose a period of PBT. This provision is mirrored in section 18(4a) for RBT. There is no limit in either of these sections regarding the timeframe for any variation.

As such, if seasonal conditions are such that it is considered likely that the PBT or RBT times require shortening by more than 14 days; the local government should make application to the Authority (FESA) to publish such a variation in the Gazette.

Regional staff are to ensure that local governments in their respective region are aware of the SSO interpretation of the Act, and should a local government wish to make an application to the Authority to publish a variation in the gazette; the application is to be submitted through the Regional Director.

Regional Directors are to forward any such application together with their recommendation to the FESA CEO for consideration.

Amendments will be made to the Fire Control Officer manual to reflect the SSO advice.

Part III — Prevention of bush fires

Division 2 — Prohibited burning times

17. Prohibited burning times may be declared by Minister

- (1) The Minister may, by declaration published in the Gazette, declare the times of the year during which it is unlawful to set fire to the bush within a zone of the State mentioned in the declaration and may, by subsequent declaration so published, vary that declaration or revoke that declaration either absolutely or for the purpose of substituting another declaration for the declaration so revoked.
- (2) Where by declaration made under subsection (1) prohibited burning times have been declared in respect of a zone of the State then, subject to such variations (if any) as are made under that subsection from time to time, those prohibited burning times shall have effect in respect of that zone in each year until that declaration is revoked.
- (3) A copy of the *Gazette* containing a declaration published under subsection (1) shall be received in all courts as evidence of the matters set out in the declaration.
- (4) Where the FES Commissioner considers that burning should be carried out on any land, the FES Commissioner may suspend the operation of a declaration made under subsection (1), so far as the declaration extends to that land, for such period as the FES Commissioner thinks fit and specifies and subject to such conditions as may be prescribed or as the FES Commissioner thinks fit and specifies.
- (5) The FES Commissioner may authorise a person employed in the Department to regulate, permit or define the class of burning that may be carried out, and the times when and conditions under which a fire may be lit, on the land referred to in subsection (4) during the period of suspension granted under that subsection.
- (6) In any year in which the FES Commissioner considers that seasonal conditions warrant a variation of the prohibited burning times in a zone of the State the FES Commissioner may, by notice published in the *Gazette*, vary the prohibited burning times in respect of that year in the zone or a part of the zone by
 - (a) shortening, extending, suspending or reimposing a period of prohibited burning times; or
 - (b) imposing a further period of prohibited burning times.
- (7) Subject to subsection (7B), in any year in which a local government considers that seasonal conditions warrant a variation of the prohibited burning times in its district the local government may, after consultation with an authorised CALM Act officer if forest land is situated in the district, vary the prohibited burning times in respect of that year in the district or a part of the district by
 - (a) shortening, extending, suspending or reimposing a period of prohibited burning times; or
 - (b) imposing a further period of prohibited burning times.

- (7B) A variation of prohibited burning times shall not be made under subsection (7) if that variation would have the effect of shortening or suspending those prohibited burning times by, or for, more than 14 successive days.
 - (8) Where, under subsection (7), a local government makes a variation to the prohibited burning times in respect of its district or a part of its district the following provisions shall apply
 - (a) the local government
 - (i) shall, by the quickest means available to it and not later than 2 days before the first day affected by the variation, give notice of the variation to any local government whose district adjoins that district;
 - (ii) shall, by the quickest means available to it, give particulars of the variation to the FES Commissioner and to any Government department or instrumentality which has land in that district under its care, control and management and which has requested the local government to notify it of all variations made from time to time by the local government under this section or section 18;
 - (iii) shall, as soon as is practicable publish particulars of the variation in that district;
 - (b) the Minister, on the recommendation of the FES Commissioner, may give notice in writing to the local government directing it—
 - (i) to rescind the variation; or
 - (ii) to modify the variation in such manner as is specified in the notice;
 - (c) on receipt of a notice given under paragraph (b) the local government shall forthwith
 - (i) rescind or modify the variation as directed in the notice; and
 - (ii) publish in that district notice of the rescission or particulars of the modification, as the case may require.
 - (9) For the purposes of subsection (8)
 - publish means to publish in a newspaper circulating in the district of the local government, to broadcast from a radio broadcasting station that gives radio broadcasting coverage to that district, to place notices in prominent positions in that district, or to publish by such other method as the FES Commissioner may specify in writing.
- (10) A local government may by resolution delegate to its mayor, or president, and its Chief Bush Fire Control Officer, jointly its powers and duties under subsections (7) and (8).
- (11) A local government may by resolution revoke a delegation it has given under subsection (10) and no delegation so given prevents the exercise and discharge by the local government of its powers and duties under subsections (7) and (8).
- (12) Subject to this Act a person who sets fire to the bush on land within a zone of the State during the prohibited burning times for that zone is guilty of an offence. Penalty: \$10 000 or 12 months' imprisonment or both.

Division 3 — Restricted burning times

18. Restricted burning times may be declared by FES Commissioner

- (1) Nothing contained in this section authorises the burning of bush during the prohibited burning times.
- (2) The FES Commissioner may, by notice published in the Gazette, declare the times of the year during which it is unlawful to set fire to the bush within a zone of the State mentioned in the notice except in accordance with a permit obtained under this section and with the conditions prescribed for the purposes of this section, and may, by subsequent notice so published, vary that declaration or revoke that declaration either wholly or for the purpose of substituting another declaration for the declaration so revoked.
- (3) Where by declaration made under subsection (2) restricted burning times have been declared in respect of a zone of the State then, subject to such variations (if any) as are made under that subsection from time to time, those restricted burning times shall have effect in respect of that zone in each year until that declaration is revoked.
- (4) A copy of the *Gazette* containing a declaration published under subsection (2) shall be received in all courts as evidence of the matters set out in the declaration.
- (4a) In any year in which the FES Commissioner considers that seasonal conditions warrant a variation of the restricted burning times in a zone, or part of a zone, of the State the FES Commissioner may, by notice published in the *Gazette*, vary the restricted burning times in respect of that year in the zone or part of the zone by
 - (a) shortening, extending, suspending or reimposing a period of restricted burning times; or
 - (b) imposing a further period of restricted burning times.
 - (5) Subject to subsection (5B) in any year in which a local government considers that seasonal conditions so warrant the local government may, after consultation with an authorised CALM Act officer if forest land is situated in its district
 - (a) vary the restricted burning times in respect of that year in the district or a part of the district by
 - (i) shortening, extending, suspending or reimposing a period of restricted burning times; or
 - (ii) imposing a further period of restricted burning times;

or

- (b) vary the prescribed conditions by modifying or suspending all or any of those conditions.
- (5B) A variation shall not be made under subsection (5) if that variation would have the effect of
 - (a) shortening the restricted burning times by; or

- (b) suspending the restricted burning times, or any prescribed condition, for, more than 14 successive days during a period that would, in the absence of the variation under subsection (5), be part of the restricted burning times for that zone in that year.
- (5C) The provisions of section 17(8), (9), (10) and (11), with the necessary adaptations and modifications, apply to and in relation to the variation of restricted burning times or prescribed conditions by a local government, as if those provisions were expressly incorporated in this section.
- (5D) In subsections (5) and (5C) prescribed condition includes the requirement of subsection (6)(a).
 - (6) Subject to this Act a person shall not set fire to the bush on land within a zone of the State during the restricted burning times for that zone of the State unless
 - (a) he has obtained a permit in writing to burn the bush from a bush fire control officer of the local government in whose district the land upon which the bush proposed to be burnt is situated, or from the chief executive officer of the local government if a bush fire control officer is not available; and
 - (b) the conditions prescribed for the purposes of this section are complied with in relation to the burning of the bush.
 - (7) The person issuing a permit to burn under this section may, by endorsement on the permit
 - (a) incorporate therein any additional requirements and directions considered necessary by him relative to the burning; or
 - (b) modify or dispense with any of the conditions prescribed for the purposes of this section in so far as those conditions are applicable to the burning.
 - (8) The holder of a permit to burn under this section
 - (a) shall observe and carry out any requirement or direction incorporated therein pursuant to subsection (7)(a);
 - (b) shall, where any prescribed condition is modified pursuant to subsection (5) or subsection (7)(b), comply with that condition as so modified;
 - (c) need not comply with any prescribed condition that is suspended or dispensed with pursuant to subsection (5) or (7)(b).
 - (9) A permit issued under this section may authorise the owner or occupier of land to burn the bush on a road reserve adjoining that land.
- (10A) Subject to the regulations a local government may by resolution declare that within its district bush may be burnt only on such dates and by such persons as are prescribed by a schedule of burning times adopted by the local government.
- (10B) A person desiring to set fire to bush within the district of the local government that has made a declaration under subsection (10A) shall, by such date as may be determined by the local government, apply to the local government for permission to set fire to the bush, and the local government shall allocate a day or days on which the burning may take place.

- (10C) Any burning permitted under subsection (10B) shall be done only on the day or days and in the manner specified by the local government and subject to the conditions prescribed for the purposes of this section except that any prescribed period of notice may be varied by the local government in order to enable the schedule of burning times adopted by it to be given effect to.
- (11) Where a person starts a fire on land, if the fire escapes from the land or if the fire is in the opinion of a bush fire control officer or an officer of a bush fire brigade out of control on the land, the person shall be liable to pay to the local government on the request of and for recoup to its bush fire brigade, any expenses up to a maximum amount of \$10 000 incurred by it in preventing the extension of or extinguishing the fire, and such expenses may be recovered in any court of competent jurisdiction.
- (12) A person who commits a breach of this section other than subsection (11) is guilty of an offence.

Penalty: For a first offence \$4 500.

For a second or subsequent offence \$10 000.

RE: FEEDBACK SOUGHT ON EXTENDING RESTRICTED BURNING PERIOD WITHIN THE POINT HENRY PENINSULA

The local Volunteer Bush Fire Brigades in conjunction with the Shire of Jerramungup have met and discussed extensively the threat of fires escaping in the Point Henry Peninsula from controlled burns. Point Henry is the highest bushfire risk area in the Shire with its unique topography, vegetation and landscape. Any out of control fire activity in this area has significant impacts on our local brigades and the community with the potential loss of life being the major concern for all agencies.

When reviewing the 2015/2016 fire season it was decided that investigation and consultation needs to be undertaken regarding an extension to the restricted burning period in Point Henry. To date the Shire has implemented a new fire zone (Zone 5-Point Henry Peninsula) which you will see on the attached map. The purpose of this new fire zone is to allow local volunteer fire fighters greater knowledge of who is burning in the Peninsula and to create a safer and more controlled environment for residents who utilise burning as a means of bushfire mitigation and preparedness.

We are now seeking your feedback on an extension to the restricted burning period in Point Henry. The restricted burning period requires landowners to obtain a permit from a Fire Control Officer which will set out a number of conditions under which a burn will be permitted. Attached to this letter is also a Mitigation Information Session Hand out from our recent workshop which contains a sample permit. The two proposals are provided below with the first indicating that permits would be required at all times outside the prohibited season and a second where permits would not be required during winter months. Given the prevalence of absentee landholders in Point Henry the current restriction on Sunday and public holiday burning within the restricted burning period is also being reviewed to provide landowners with wider opportunity to conduct mitigation on weekends.

Your feedback and comments are valued to inform our decision making process and are required by Friday 22nd April 2016. The Shire of Jerramungup Bushfire Advisory Committee Annual General Meeting will be held on 27th April 2016 and the Committee may resolve to recommend that Council implement either proposal in preparation for the 2016/2017 fire season.


