

ROAD CONSTRUCTION

Swamp Road - Bremer Bay Road to Doubtful Island Road

Drainage, signage and pit reinstatement works are approaching completion. This will finalise the intended scope of works for 2011 / 2012.

Devils Creek Road – Devils Creek South Road eastward for 5 kilometres

Sealing has been undertaken for 5 km eastward of Devils Creek South Road with only minor works remaining for project completion.

Preparations are proceeding for extension of the seal another 5 km eastwards during 2012 / 2013.

Gairdner South Road - Various

Repairs are in progress to address a number of pavement failures.

Swamp Road – Vicinity of Devils Creek South Road.

Forming, drainage and gravel sheeting improvements have been undertaken on Swamp Road from approximately 3 km east to 3 km west of Devils Creek South Road.

Signage and pit reinstatement will complete this project.

<u>Jerramungup</u>


Contractor Correctline Drainage has arranged defect correction at Jerramungup.

The sealing of pavement repairs undertaken by the Shire on Derrick Street, have been disrupted by inclement weather and contractor availability.

It is recommended that the completion of resealing to Derrick Street is included in the 2012 / 2013 budget.

Generally projects at Bremer Bay and Gairdner are to be completed before commencing forming and gravel sheeting on Rabbit Proof Fence and Cameron Roads.


The expenditure status of the Road Construction Programme is indicated below.



ROAD MAINTENANCE

The attached reports indicate where road maintenance was undertaken during May for Bremer Bay, Jerramungup and the rural area.

As indicated below, expenditure is at an acceptable level however recent storms demand a reassessment of priorities.



Heavy rainfall in the Bremer Bay and Gairdner localities on 31 May 2012, has resulted in moderate overall damage, with Native Dog Beach and Little Boat Harbour Roads being most affected and culvert silting resulting from severe erosion of the table drains and road shoulders.

Native Dog Beach Road is of greatest concern. Stabilising the table drains and restoring the drainage before further erosion impacts the sealed carriageway, is a high priority.

The photographs below are indicative of Native Dog Beach Road erosion and silting of culverts. A Flood Damage submission will be prepared.






Strong winds on 10 June 2012 resulted in the falling of many trees and removal from roads is a priority.

The purpose of the report is to seek formal support for the enacting of legislation by the Western Australia Police, on reserves managed by the Shire of Jerramungup.

BACKGROUND

The Western Australia Police have contacted the Shire of Jerramungup to determine the Shire's position with regard to the enacting of legislation, by the Police, on reserve land (other than road reserves) managed by the Shire of Jerramungup.

It is understood that the request has arisen following the challenging of a traffic infringement, which was issued on Shire of Jerramungup managed Reserve 511. Reserve 511 is for the purpose of Recreation and includes the Fisheries Beach Marina and the Bremer Bay Golf Club.

The request by the Western Australia Police is not however specific to Reserve 511 and extends to other areas including John Cove where beyond Cuneo Drive, Bremer Bay Road is also on reserve land managed by the Shire of Jerramungup for the purpose of Camping, Caravan Park and Recreation.

CONSULTATION

Western Australia Police is consulting with the Shire of Jerramungup.

COMMENT

The Shire of Jerramungup has a limited capacity and authority to enact legislation. Western Australia Police provides valuable support to the Shire of Jerramungup, particularly during peak holiday periods at Bremer Bay.

Although the Western Australia Police also has a limited capacity, a collaborative arrangement with the Shire of Jerramungup is mutually and socially beneficial.

COMMENT

Ideally a local government boundary would be at the rear of titles, so that a property and the servicing road are within the same local government.

Alternatively, a local government boundary coinciding with a road reserve boundary places a road entirely within a single municipality. Responsibility is clearly established, notwithstanding that some properties serviced might be within an adjoining local government.

In the case of the Shires of Jerramungup and Gnowangerup the:

- a) Common boundary is along the centreline of road reserves.
- b) Majority of roads along the common boundary, are maintained by the Shire of Jerramungup.

Amendment of the common boundary to define and separate Shire of Jerramungup and Shire of Gnowangerup responsibilities would be advantageous.

As an interim measure, a memorandum of understanding with the Shire of Gnowangerup might be considered.

The routine maintenance expenditures indicated:

- a) For Boxwood Ongerup and Rabbit Proof Fence Roads are proportioned from the total for the entire road length.
- b) Are for routine maintenance only and exclude construction and flood damage amounts.

Corackerup and Monjebup Roads, in particular have a well defined natural drainage system, which provides certain advantages but also concentrates flows and places a greater emphasis on drainage structures.

It is unlikely that Yate Road, for example, would be upgraded to the same standard as Corackerup Road.

It is likely however that an average of \$30,000 per kilometre to form, improve drainage and gravel sheet the roads currently maintained by the Shire of Jerramungup, being a total cost of \$1.5 million, would be conservative.



The recommend transfers to restricted cash and reserves have been recommended to Council to ensure that projects which are carried forward into next financial year are financed with 2011/2012 funds and to increase Council reserve funds for financing future year's projects.

In the case of the Point Henry Fire Levy unutilised funds can be used in later years for more significant upgrades to fire management infrastructure on the Point Henry Peninsula.

COMMENT

The following transfers are recommended for approval, which are beyond the original adopted transfers included in the 2011/2012 budget.

- 1) Transfer to Capital Works Reserve: Unutilised funds associated with the pending grant application for the Roe Park Synthetic Surface \$55,000.
- 2) Transfer to Capital Works Reserve: Remaining planning funds for the Paperbarks Park Upgrade \$10,000
- 3) Transfer to Plant Reserve \$23,078 in unutilised plant funds due to savings in plant purchases.
- 4) Transfer to the Community Recreation Reserve \$19,406 in unutilised funds allocated for Council's contribution towards projects eligible for funding under the Department of Sport and Recreation's CSRFF program.

5) Transfer to Point Henry Fire Levy Reserve: \$21,010 in revenue was collected through the Point Henry Fire Levy in 2011/2012. A total of \$8,748 was spent to 30th May 2012 and there are no additional expenditure plans for the remainder of this financial year. This leaves a net transfer of \$12,262.

BACKGROUND

Council's current finance policies have been reviewed recently by staff. Although some of the policies require minor amendments, significant amendments are recommended to the 'Grants to Community and Sporting Groups Policy. The reasons and justification for this significant amendment is outlined within the 'Comments' section of this report.

Attached to the agenda are the current policies and a set of revised finance policies for Council adoption.

COMMENT

The attached new set of Council policies is presented for adoption and inclusion in Council's policy manual. The following commentary is provided on amendments and new inclusions:

Finance Policy 4: Grants to Community and Sporting Groups

Summary

The proposed changes to this policy are significant. Previously, this policy provided 2.5% of the previous years rates income and made this income available to Community and Sporting Organisations. Traditionally, the funding was used towards sport and recreation infrastructure and as the Shire's 1/3 contribution towards Community Sporting and Recreation Facilities Fund (CSRFF) projects.

In response to a recent approach for financial support, it was seen as appropriate to recommend changes to the policy to include a distribution of funds to individuals. The proposed amendment would facilitate a Shire contribution of up to \$500 towards travel and accommodation when a resident is selected to participate in either a National or International sporting event outside of Western Australia.

Proposed changes and rationale

The proposed changes include;

- Amending the policy title from 'Grants to Community and Sporting Groups' to 'Sport and Recreation Grants'.
- The policy purpose has been amended to more closely align with the recreation component of the Shire's Strategic Plan.
- The policy objectives have been amended to facilitate the provision of financial support to individuals.
- The policy limitations have been expanded to provide for the distribution of funds to individuals.

Policy limitations

The proposed amendments to the policy have been drafted to include the following limitations;

- The sporting activity must be a National or International sporting event held outside of Western Australia.
- Donations are not funded retrospectively.
- Applicants must be a resident of the Shire of Jerramungup.
- Funding will only be considered after all other funding opportunities have been exhausted e.g. State and Federal Government funding.
- Funding will only be provided for up to 50% of travel and accommodation costs to a maximum of \$500.
- The travel/accommodation subsidy donation is only available to participants. Coaches, support staff and chaperones are not eligible to apply for funding.
- Selected representatives are entitled to one subsidy donation per activity in any one financial year.
- If the situation arises that the successful applicant does not attend the competition the monies shall be reimbursed to the Shire.

Justification

The proposed policy amendments are in response to a recent request for assistance to attend a National Hockey Carnival in Hobart as a part of the Western Australian U/16 State Team.

The Shire was engaged very early in the process with assistance provided through the Shire's Club Development Officer. In investigating the funding available, it became apparent that different sports and various demographic profiles draw varying degrees of funding. In this instance, there is a significant funding gap due to the carnivals non affiliation with Hockey WA.

In investigating this issue, the Shire has identified that a significant gap exists within the system. This is not an isolated issue and if left unresolved, it could place significant limitations on our community's capacity to attend sporting events outside of Western Australia.

It is the author's opinion that if a resident is selected to participate at an elite level, then the financial capacity of the individual or the individual's family should not prohibit or restrict the individual from competing.

It is also noted that 100% funding is not appropriate and that the participant should make a contribution of some description. For this reason, the policy limitations will only provide a contribution towards 50% of the travel and accommodation costs to a maximum amount of \$500.





PROJECT UPDATE

1) Jerramungup Residential Land Developments

Bremer Bay Realty has been appointed to sell the blocks. The blocks are now advertised on www.realestate.com.au.

Some interest has been received, however offers are not forthcoming.

2) Farmland Water Response Planning

The DEC has refused the clearing application and therefore the works cannot proceed. Alternative sites are being investigated, however it is likely that the funding will expire and the Shire will need to reapply in 2012/13.

3) Industrial Land Bremer Bay

The Shire has been advised that the subject property has been sold. The Shire has met with the new owner to ascertain their interest in developing the subject land.

The new owner has been asked to consider an alternative proposal whereby 20ha is rezoned for industrial purposes.

The Shire is yet to receive a response from the owner.

4) Bremer Bay Medical Centre

The Department for Health has commissioned a Health Services Plan to be completed for Bremer Bay and Jerramungup.

A series of community meetings were held in May 2012. A preliminary report has been received summarising the outcomes.

Aurora Projects (consultant) will provide the report and then the information in it will be verified. When the key stakeholders agree that the report is accurate, the report will go to the Regional Director for consideration.

5) Bremer Bay Town Centre

The final structure plan was adopted by Council in April 2012. The Shire has met with Landcorp and reviewed a Servicing Report for the subject site.

The Shire has been advised formally that the Department for Education is in agreement with the land swap providing that the school site can be maintained at 4ha. This land swap will be subject to Native Title and therefore may take some time to complete.

6) Town Site Revitalisation - Jerramungup

The Fitzgerald Biosphere Garden is essentially complete with a majority of the plant species being sourced, successfully propagated and now planted.

The only remaining component is the manufacture of signs. The signage component will exceed the Shire's capacity this financial year and will need to be considered in the 2012/13 budget process.

7) Strategic Waste Management

The final business case has been received by the Shire. Funding has been approved by the Department for Regional Development and Lands.

Drilling has concluded on the Ravensthorpe site with Council to consider dual management of the site within the coming months.

Tenders will be called in August for the detailed design of this site.


