We thank you for your time taken and careful consideration in relation to our proposed plan.

We are eager to cover all concerns in an aim to reach an acceptable and happy outcome for all.

1. The process to move the building envelope to its current position in 1997/98 was flawed and it shouldn't have been moved.

The current location of the building envelope was a main factor of us purchasing the property and is shire approved.

2. The increase in population will increase fire risk.

We ourselves are very conscious of the fire risks of living on the Point Henry Peninsula. Having run a B&B in a similar location over the past 3 years we feel extremely confident with;

- 1. Guest awareness of fire safety on the Peninsula using FESA and Shire Council information.
- 2. Our B&B advertising is aimed at people wanting a "hotel like experience" Our guests are inside or on the deck or off seeing the sites of Bremer Bay, not camping, bush walking etc.
- 3. We estimate 98% of our B&B guests are mature and retired couples. They are sensible, educated and overall very considerate in all things.
- 4. Our Building envelope is being planned with fire safety in mind and will be maintained with the highest attention to do our bit in keeping our family, guests and the surrounding families safe as a part of the greater Point Henry Peninsula Community.
- 5. We are only a family of 4, however if we were a family of 10 building in a residential capacity it would not be required to go to council.

3. The separate building may result in greater noise issues, especially as the Building Envelope has been moved;

- 1. We decided on a split house design to ensure our visual impact is as low as possible for our neighbors, guests and ourselves.
- 2. We set the example of a quiet, peaceful lifestyle and our guests follow suit.
- 3. Our advertising suggests "relaxing, quiet, secluded, home away from home" and this is the cliental we get.
- 4. Our guest will have breakfast with us each morning in our house and therefor still feel part of our family while they are with us.
- 5. The prevailing winds are from the east and any noise (which we are not expecting any) will be blown up to Point Henry Road.

4. Concern that visitors will trespass through neighboring properties.

- 1. Experience has shown that our guests are most often city folk who are petrified of snakes and are very careful to keep to the house. Also by day they are busy off seeing the sites as they are normally only staying 1 or 2 nights.
- 2. We will be happy to put up a sign at the boundary point to let people know that it is the end of our property.
- 3. We also educate our guests over breakfast as to how to get to the nearest beaches and hotspots. Being elderly they almost always take their cars.
