#### 5.2 Street numbering

Jerramungup VFES unit are waiting for warmer weather for the pavement to meet recommended temperature range of 18\*C - 24\*C, prior to commencing around Jerramungup town site as per paint instructions. There were concerns raised by the Unit that the paint will only last for approx. 1-2 years pending on volume of traffic instead of 5 years as previously advised.
