## 4.0 BUSINESS ARISING FROM MINUTES

#### 4.1 TRAINING – JANNA C.

Bushfire Safety Awareness and Fire Fighting Skills training has been held in multiple locations and most BFB volunteers have attained the minimum training standard required for attending a fireground within the Shire of Jerramungup. Completed

#### 4.2 LOCATION OF MISSING RADIOS- ANTHONY A.

## 4.3 ORIGO WEATHER STATIONS - JANNA C.

The Shire investigated joining the private Origo Weather Station network, which includes over 50 stations within our Shire. Origo advised an annual cost of \$100 per selected station to create a dashboard displaying chosen sites. The committee discussed selecting a few strategic stations but resolved to continue using publicly available weather data and conduct local Kestrel readings when required. Completed

#### 4.4 UHF HANDHELD RADIOS FOR BOXWOOD HILL BFB – JANNA C.

Two UHF radios have been procured and provided to the Boxwood Hill BFB. Completed

#### 4.5 REVIEW OF LOCAL LAW - MARTIN C.

No feedback has been received from public during advertising period. Draft local law now awaiting feedback from the standing committee before it can be implemented. Ongoing

## 4.6 REVIEW OF FIRE CONTROL POLICY 7 – CAMPING AND COOKING FIRES – JANNA C.

The committee will receive the draft policy for review at the April 2026 meeting, as no progress has been made to date. The committee discussed expired fire pit registrations. It was suggested that expired permits be extended for 12 months or until the policy review is completed, whichever occurs first. Charmaine recommended excluding permits for properties where ownership has changed since registration.

Action: Shire to provide list with expired fire pit registrations to Peter Buckenara and Alex Jones for review and actioning of permit extension for a 12 month period only whilst the policy is being reviewed.

## 7.2 COMCEN NOTIFICATION WHEN RESPONDING TO AN INCIDENT

During the recent Level 1 Incident Controller course, it was noted that brigades must notify COMCEN when mobilising, arriving at, departing from, and returning from incidents. To reduce phone calls, Alex Jones will record attendance and update COMCEN on behalf of the bushfire brigades. Captains must

ensure the CBFCO is advised whenever volunteers turn out, including names and appliances. VFES brigades to adhere to their operating procedures.

#### 7.3 FIREMAPPER FOR BRIGADES

FireMapper licensing and initial Shire setup have been completed. The CESM will now create brigade licences and install the app on iPads. Once setup is finalised, iPads, cases, and mounts will be issued to Bushfire Brigades. A brief demonstration of the app was provided to the group during the meeting.

## 8.0 ROUND TABLE

#### **Alex Jones**

Expressed his appreciation to everyone for their participation in training activities.

Commended Peter Buckenara for his outstanding achievement as a finalist in the individual WAFES Awards.

Informed about upcoming radio roll calls with prior WhatsApp notification.

Sought feedback from CEO to identify further training pathway for volunteers. In answer Martin suggested for CBFCO, CEO/DCEO and CESM to meet and discuss opportunities for upskilling, capacity building and succession planning amongst volunteer brigades.

#### Martin Cuthbert:

Congratulated Peter Buckenara on individual achievement and award nomination. Expressed thanks and gratitude to volunteers for their commitment to their community and for participating in this year's training activities.

## **Charmaine Wisewould:**

Advised the committee that many properties were identified as non-compliant during this year's inspections. The main issues related to blocked access caused by locked gates or alarm systems. Notices have been issued, giving landowners 14 days to achieve compliance before reinspection. Non-compliant properties will incur a \$250 fine, and the Shire will engage a contractor to complete required works, with costs billed to landowners. Biodiverse are also preparing a new georeferenced PDF map showing compliant water tanks/couplings and strategic breaks. This will be able to be used via Avenza Maps to assist firefighters with up-to-date tank location and access. Only fully compliant tanks were GPS'd, with checks on water level, coupling size/location, tank size and accessibility.

## Michael Lester

Requested additional Kestrels for Jacup BFB.

Informed all about upcoming Jacup BFB pre season training and Seasonal Workers Fire Awareness session being held at Jacup BFB shed on Thursday 23/10/25 commencing at 07:00.

**Action:** CESM to procure resources.

## Janna Cheshire

Informed committee that SOSF appliances (high season appliances) have been allocated with one light tanker being delivered to Bremer Bay this week and the Boxwood heavy duty appliance remaining at the Boxwood Hill BFB shed.

Showed committee the DFES lived experiences video featuring Tim Haslam's story.

## **KEY ACTIVITIES:**

## 1. Volunteer Training Focus

Thank you to everyone that has participated in recent training courses and activities. We have now completed the minimum training standard for most of our BFB volunteers. Additionally, we have also 8 newly qualified Level 1 incident controllers. Well done to you all.

#### 2. Review of Fire Control Information Brochure

This year, we have trialled a new fire control and hazard reduction information brochure, with content now streamlined into a concise, double-sided A4 flyer to be distributed alongside this year's rates notices. Much of the previously printed detail has been transitioned to the Shire's website, with the flyer featuring a web address and QR code for easy access. Feedback is welcome.

## 3. 000 Arrangement - change to group call

As discussed at the last BFAC, a group call has been created to answer any incoming 000 calls for the Shire of Jerramungup Bushfire Brigades. The procedure has been emailed to group contacts. Test call to be conducted tonight.

## Shire of Jerramungup MAF R2 24/25

Majority of this year's treatments have been finished.

A few spraying jobs and mechanical work in Jerramungup to be completed prior to the high threat period.

## **Prescribed Burning**

- 1. Needilup Townsite
- 2. Boxwood Hill Townsite
- 3. Bremer Bay LIA pile burns
- 4. North of Beaches Caravan Park (two small sections)
- 5. North of Whitetrail Rd (one small section opposite Noongar camp)
- 6. Point Henry Rd Pile burn- Tea Tree piles.

Jerramungup Shire expressed our interest and was successful in getting onto the next round of MAF 3-year funding. Application has been lodged with DFES and we are waiting for confirmation of funding.
