SUMMARY:

This item seeks Council's endorsement of the Development Agreement between the Minister of Education and the Shire of Jerramungup for the management of the project works associated with the Jerramungup Swimming Pool redevelopment.

BACKGROUND:

The Shire is currently delivering works associated with the redevelopment of the Jerramungup Swimming Pool at 2 Lancaster Road in Jerramungup. The tenure of the project site is with the Department of Education, notwithstanding the current lease agreement extends the management of the site to the Shire of Jerramungup.

As a condition of the Department of Education agreeing to the redevelopment of the site, they require a development agreement between the Minister of Education and the Shire of Jerramungup to be in place prior to the commencement of any construction works.

The Minister has agreed to permit the Shire to undertake the Development on the Land in accordance with the provisions of this Agreement, including the:

- (a) grant of the Development Licence to permit construction of the Development; and
- (b) the Minister granting the Shire the Licence.

The draft Development Agreement and Independent Certifiers Deed has been developed by the Department of Education and is attached for Council's review.

CONSULTATION:

COMMENT:

The Development Agreement sets out procedures to which Council is expected to manage and deliver the project and associated works.

The nature and structure of the agreement has been reviewed by the administration and other key stakeholders and presents reasonable and practical.

The Independent Certifier Deed stipulates the terms and conditions under which the Independent Certifier will perform its services and is executed by the Minister, the Shire and the Independent Certifier. The Shire has engaged Statewide Building Certification WA to fulfil this role as part of the consultancy team that was engaged at the beginning of the project and costs for this service are accounted for in the existing budget.

The Independent Certifier's role is to:

- independently certify in accordance with the Independent Certifier Deed that:
- the design documentation for the final design for the Development is appropriate for construction purposes and complies with the Development Plans and Specifications;
- the Works comply with the requirements of the final design and the Specifications;
- Practical Completion has been achieved; and
- all defects have been rectified within the Defects Liability Period;
- provide the State's Representative with a written report on any matter required by the State's Representative in relation to any compliance certificate; and
- perform all other functions in accordance with the Independent Certifier Deed.

The Independent Certifier is obliged to act independently of the Minister, the Shire, the Contractor and any of the Contractor's subcontractors.

The review has not identified any contentious matters that impart undue risk or burden on Council beyond what is reasonably expected when undertaking management of a project of this nature.
